Background:

Nationality bias is a documented issue in many judged Olympic sports

How figure skating is judged:

- 5 elements per performance,
 9 judges per element
- Elements scored from -3 to 3

BuzzFeed scoring database from GitHub

- All major international competitions Oct 2016 Dec 2017
- Separate .csv files for judges, events, elements, performances
- Subsetted for 2017 WC, cleaned and merged data into one data frame
- 32 performances x 5 elements x 9 judges = 1,440 data points



Methodology


- Mean = mean score of the panel
- Standard score = individual score mean of panel
- AoA: Average of all standard scores of a single judge
- AoM: Average of matched standard scores of a single judge
- DoD=AoM AoA
- Overall DoD= overall AoM overall AoA
- Matches between Judge Nation & Athlete Nation

Overall Distribution of Standard Scores




Distribution of Matched VS All Standard Scores



A first look at bias


- Number of match elements: 80






